Description of Tennis Volunteer Involvement:

Peter has been a volunteer in Wisconsin, Florida and Arizona. In Wisconsin (60's and 70's), he helped form the Wisconsin Tennis Patrons (the non-profit fund raising arm of the Wisconsin Tennis Association) and was an original Board Member. He was also a Board member of the Wisconsin Tennis Association for at least 6 years.
